1. Round Up Ready Alfalfa/Common Weed Rules for Peace Region

Nasar reviewed the discussions held at the Peace Region ASB Chairs and Fieldmen meeting held in Edmonton on January 25, 2017 regarding Roundup Ready Alfalfa and Common Weed Rules for the Peace Region.

Nigel Thorne:

MOVED that the Agricultural Service Board educate and lobby locate

farmers and request their input on whether or not Roundup Ready

Alfalfa should be grown in the Peace region.

The Board felt that an article should be placed in the local newspaper as well as on the website and on Facebook advising ratepayers about the implications of Roundup Ready alfalfa and asking them for their input.

It was suggested that the Manager of Ag Services request that farmers who wish to receive updates on Roundup Ready alfalfa or other agricultural issues could provide the M.D. with their email addresses.

The M.D. of Peace Agricultural Service Board supports the Peace region motion that wa passed recommending that the Peace Region AAAF review and create a list of elevated weeds, commonalities and discrepancies, in order to create Regional Guidelines for common weeds in the Peace region.

Nasar advised that he will be doing weed inspections himself in areas where Scentless chamomile has previously been located.

George Leger joined the meeting at 10:17 a.m.

Roadside ditches will be sprayed north of Highway 2 this year, as well as in areas that require additional control using the utility vehicle. The program for the M.D. staff to spray fencelines in the fall at no charge will continue in the fall of 2017.

The ditch brushing/mulching program will also continue in 2017.

### 3. ASB Summer Staff Hiring and Wages

The two mower operators will be returning in 2017, commencing with rock picking early in the spring, then mowing roadside ditches when appropriate. A dump trailer will have to be purchased in 2017 for the rock picking. The weed inspector and sprayer operator will also be returning for the 2017 season. In 2016, \$22/hour was paid to the mower operators

# 4. Agriculture for Life - Field Signage - What's in the Field

This program provides information signs to educate travellers about different types of crops being grown. At this time, there is no limit to the number of signs provided in a municipality. These signs will be placed along main highways in the fields, near the road ditches. The signs will be provided in May and will have the producer's name on the sign as well as the crop being grown. The signs must be requested by the producer with the producer erecting and dismantling the signs. It was suggested that the Manager of Ag Services should contact various producers who have land adjacent to Highway 2 in the M.D. of Peace and that the program should also be advertised. The Board suggested that one sign for each type of crop should be sufficient.

5. Request for Sponsorship - Alberta Farm Fresh Producers Association
The Board accepted for information only the letter received from Alberta Farm
Fresh Producers Association requesting sponsorship for the 2017 Farm to
Market Conference to be held in Olds, Alberta.

# 6. Living with Wildlife Workshop - February 23

# 7. Solar Workshop

Nasar asked the Board if the M.D. of Peace should host a local workshop educating ratepayers on solar energy use. The Board felt that the Manager of Ag Services should research hosting a local workshop as costs for installing solar energy have reduced and technology has improved. It was mentioned that Can-Tech Electrical may be installing panels locally.
