

BYLAW NO. 1/2020

**BEING A BYLAW OF THE
MUNICIPAL DISTRICT OF PEACE NO. 135
IN THE PROVINCE OF ALBERTA**

FOR THE PURPOSE OF ESTABLISHING AND REVISING VARIOUS FEES AND CHARGES

WHEREAS, Section 7 of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, provides that a Council may pass bylaws for municipal purposes respecting services provided by or on behalf of the municipality, and

WHEREAS, the Council of the Municipal District of Peace No.135 deems it appropriate to impose fees and charges as outlined in "Schedule A" of this Bylaw, which forms part of this Bylaw.

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL DISTRICT OF PEACE NO. 135, IN THE PROVINCE OF ALBERTA, DULY ASSEMBLED, HEREBY ENACTS AS FOLLOWS:

1. That the purpose of this Bylaw is to impose fees and charges for various services provided by the Municipal District of Peace No.135.
2. That this Bylaw may be cited as the "Fees and Charges Bylaw".
3. That the Municipal District of Peace No.135 imposes fees and charges in accordance with "Schedule A" of this Bylaw. Any amendments to these fees and charges may only be done by Bylaw.
4. That should any provision of this Bylaw be invalid, then such invalid provision shall be severed and the remaining Bylaw shall be maintained.
5. That Bylaw No. 18/2018 be repealed upon the effective date of Bylaw No. 1/2020.
6. That this Bylaw shall come into force and effect on January 14, 2020.
