BYLAW NO. 6/2023 MUNICIPAL DISTRICT OF PEACE NO. 135 IN THE PROVINCE OF ALBERTA

A BYLAW OF THE MUNICIPAL DISTRICT OF PEACE NO. 135 FOR THE PURPOSE OF IMPOSING PENALTIES ON UNPAID PROPERTY TAXES

WHEREAS, the *Municipal Government Act* RSA 2000, c M-26 authorizes a Council, by Bylaw, to impose penalties for the non-payment of property taxes;

NOW THEREFORE, the Council of the Municipal District of Peace No. 135, in the Province of Alberta, duly assembled, hereby enacts as follows:

1. Title: "Tax Penalty Bylaw."

2. Purpose:

- a) To set the due date for the payment of property taxes;
- b) To set the rates of penalty to be imposed for failure to pay property taxes by the due date.

3. Definitions:

- a) "Tax Year" means the annual period in which Taxes are imposed, commencing with January 1 and ending with December 31;
- b) "Tax Arrears" means all Taxes which remain unpaid after December 31 of the year in which they were imposed.

4. Property Tax Due Date:

- a) That current taxes levied in any year shall be due and payable on or before June 30th, providing thirty (30) days' notice has been given.
- b) That should the 30th day of June in any year fall on a weekend, the tax due date shall be the next business day with the penalty imposed the day following.

5. Penalties:

a) That providing the tax notices have been mailed for a minimum of thirty (30) days, a penalty of one percent (1%) be imposed on unpaid current taxes on:

July 2 or first day after due date if June 30 falls on a weekend

August 2

September 2

October 2

November 2

December 2.

b) That in the event of any taxes remaining unpaid after December 31 of the year for which they are levied, a penalty of ten percent (10%) shall be added on January 15th of the following year and a penalty of one percent (1%) on the unpaid arrears balance added on:

February 2	August 2
March 2	September 2
April 2	October 2
May 2	November 2
June 2	December 2
July 2	

and every year thereafter as long as the taxes remain unpaid.

- c) That any penalty so added shall be added to and shall form part of the unpaid taxes.
- 6. That Bylaw No. 7/2020 shall be repealed upon the passing of this Bylaw.
- **7.** That this bylaw shall take effect on the date of the passing of the third and final reading.
- **8.** Should any provision of this Bylaw be invalid then such invalid provision shall be severed and the remaining Bylaw shall be maintained.
