## BYLAW NO. 9/2023 MUNICIPAL DISTRICT OF PEACE NO 135 2023 PROPERTY TAX BYLAW

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE MUNICIPAL DISTRICT OF PEACE FOR THE 2023 TAXATION YEAR.

**WHEREAS**, the Municipal District of Peace No. 135 has prepared and adopted detailed estimates of municipal revenue, expenses and expenditures as required, at the council meeting held on April 11th, 2023 and

WHEREAS, the estimated municipal revenues from all sources other than property taxation total \$4,866,847 and:

**WHEREAS**, the estimated municipal expenses (excluding non-cash items) set out in the annual budget for the Municipal District of Peace No. 135 for 2023 total \$8,575,492; and the balance of \$3,809,145 is to be raised by general municipal property taxation; and

**WHEREAS**, the estimated amount required to repay principal debt to be raised by general municipal taxation is nil and;

**WHEREAS**, the estimated amount required for current year capital expenditures to be raised by general municipal taxation is \$20,500 and;

WHEREAS, the estimated amount required for future financial plans to be raised by municipal taxation is \$80,000; and

THEREFORE the total amount to be raised by general municipal taxation is \$3,809,145 and;
